Department Report- May 2014

Calls: There was one request for service in this reporting period, mutual aid was provided to Bridgton for a structure fire.

Meetings and Trainings: The Sweden Volunteer Fire Association met on May 22nd. The membership re-elected the Fire Chief, all association officers. The letter indicating this status will be sent by an association representative.

Department personnel will be conducting pump, water supply, and fire stream training on 5/31 and will also be performing annual hose testing. Additionally, the department will be participating in a live fire training next month in Bridgton using an acquired structure.

Monthly Expenses: Total: \$794.16. \$300.00-quarterly portion of porta-potty rental, \$117.28- diesel and gasoline, \$150.00- outside training class, \$95.00- payroll, 84.85-chainsaw maintenance supplies, \$47.03- misc. hardware.

Comments: We will be meeting with representatives of MDOT next month regarding the culvert and pavement issue in front of the station. Conflicting work and project schedules for all parties have meant that an exact date has not been set at this time.

Grant packages are currently being completed for two different projects, the bulk of which addresses wildfire concerns. While we are a small town, the wildland fire risk is very high here. Due to the terrain, levels of slash present on the forest floor, and ice storm/blowdown damage, most of our forest land fits the "worst case scenario" for wildfire operations. None of the grants applied for require matching funds.

1) A training/prevention grant that will provide us with a laptop, LCD projector, and DVD packages. This will enable us to have classroom instructional ability on a better level.

2) A grant for forestry training, operations and safety. This would cover the costs of delivery of the complete Basic Wildland Firefighter program and development of a community Firewise program, equipment to improve our access and water supply capabilities for wildland operations, and to ensure that all personnel have the same level of personal protective equipment.
